2. EVENT AUTHORITY AND ORGANISATION

2.1 The Event shall be held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsport Australia, Circuit Race Standing Regulations (CRSR), relevant Championship and/or Series Sporting & Technical Regulations as approved by Motorsport Australia, these Supplementary Regulations, and any Further Supplementary Regulations, any Bulletins issued at the Event or any instructions to Competitors that may be issued or any other technical or sporting regulations published by Motor Racing Australia Pty Ltd and authorised by Motorsport Australia.

2.2 This Event is a Club Circuit competition.

2.3 The Event may include other competitions, demonstrations and authorised activities. The Demonstrations will be in accordance with the NCR.

2.4 To be held in accordance with Motorsport Australia's Occupational Health and Safety Policy, Integrity Policies, Legal Policies, Risk Management Policies, Safety 1st Framework and any other relevant Policy.

2.5 Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia.

4. ENTRY PROCESS, FEES, WITHDRAWALS AND ORGANISERS RIGHTS

4.1 Entry Process

Entries must be completed online via the MRA website. Competitors whose entries are accepted will receive an acceptance letter and their Competition Number, Driver Name and Vehicle Make/Model displayed on the MRA website.

- 4.2.2 All entry fees include GST
- 4.2.3 MRA, the Clerk of the Course and/or Motorsport Australia reserve the right to combine categories as necessary to maximise track time.
- 4.2.4 Entries for this Event will open at 10:00 on Tuesday 23rd December 2025
- 4.2.5 Entries for this Event will close at 10:00 on Tuesday 27th January 2026

4.3 **Refund and Withdrawals**

- 4.3.1 All withdrawals must be made in writing to the Secretary of the Event.
- 4.3.2 If a withdrawal is received by the Secretary of the Event on or prior to the 23rd January the competitor is eligible for a 100% refund. Less a \$100 administration fee.
- 4.3.3 If a withdrawal is received by the Secretary of the Event on or after the 24th January, the competitor will not be eligible for any refund.
- 4.3.4 Any merchant fees paid by the competitor are not refundable.
- 4.3.5 If the event promotor allows for a roll over of an entry fee, the entry must be used at the next MRA event, and any shortfall between entries fees will be payable by the competitor.

4.4 **Organisers Rights**

- 4.4.1 The Organiser reserves the right to postpone or stop the Event in accordance with the NCR.

5. RACE OPERATIONS

5.1 **Start Procedure**

- 5.1.1 The start procedure will be conducted in accordance with the relevant 2026 Sporting Regulations, and the Circuit Race Standing Regulations (CRSR) published by Motorsport Australia.

5.2 **Grid Determination**

- 5.2.1 Grid determination for each category will be conducted in accordance with the relevant category Championship regulations.

6. LICENCE REQUIREMENTS

- 6.1 At a minimum, each driver must hold a Motorsport Australia Provisional Endorsed Circuit License.
- 6.2 Each driver must hold a current Motorsport Australia competition licence unless they comply with one of the following:
 - 6.2.1 Hold a Motorsport New Zealand competition licence or Tasman Visa valid for the event.
 - 6.2.2 Hold a minimum highest National grade licence used by a foreign ASN, together an authorisation used by ASN for the event. Competitors who hold a foreign ASN must apply to Motorsport Australia for a foreign participation (FPV). The FPV must be completed 10 days prior to the event.
- 6.3 The Organiser confirms that the Circuit to be used for this Event **will** hold the necessary Motorsport Australia Track licence for each of the activities nominated in these Supplementary Regulations.

7. INTEGRITY

Smoking including e-cigarettes and “vaping,” and any naked flame is prohibited within 3 metres of any refuelling/ or defuelling operation.

Motorsport Australia’s National Integrity Framework and relevant Integrity Policies, (including the Australian Anti-Doping Policy, Illicit Drugs in Sport (Safety Testing) Policy, and the Alcohol Policy), apply to any activity sanctioned by Motorsport Australia.

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.”; a statement that “Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

8. ACCREDITATION AND COMPETITOR PACKS

8.3 Personal Accreditation

Each driver and crew member will receive an event-accredited wristband, which must be worn at all times throughout the Event. This wristband assists event officials in verifying authorised access to specific areas. The wristband must not be removed for the entire duration of the event. Replacement wristbands will only be issued upon the return of the torn-off wristband to the Administration Office.

8.4 Driver Accreditation

Each driver will receive one event-accredited wristband.

8.5 Pit Crew Accreditation

Each crew member will receive an individual event-accredited wristband, which cannot be exchanged between individuals for the duration of the Event.

8.6 Vehicle Accreditation

Each competitor will receive an individual event-accredited vehicle pass, which must remain on the vehicle at all times during the event. Each pass will have a unique ID/number assigned to it, enabling event staff to contact you if any issues arise.

9. EVENT SCHEDULE

9.1 The Event Schedule will be published and distributed by the Event Organiser. The Event Schedule will be displayed on the Event Notice Board. The Organisers reserve the right to vary the Event Schedule.

10. DRIVERS BRIEFINGS

10.1 Drivers Briefing will be held in the Hinxman room above garage 49 at 7:45am. Make sure you have checked and your wristband for the event.

11. MEDICAL SERVICES

11.1 The Medical centre is located near the North Paddock tunnel and Marshalling area.

11.2 The medical centre is run by First Aid Australia Pty Ltd trading as Ambulance Service Australia. Ambulance Service Australia will be running under the Emergency Response Plan (ERP) and Medical Response Plan (MRP).

11.3 Medical requirements will be in accordance with Article 3.1.4.3 Alternative Medical Service/Requirements of the Motorsport Australia Medical Service Requirements at Motor Sport Events

12. GARAGE / CARPORT ALLOCATIONS

- 12.1 Garages and Carports must be booked with your entry.
- 12.2 Requests to be garaged with or near another competitor must be submitted with your entry form in the notes section.
- 12.3 Garage & Carport allocations will be released on Wednesday prior to the Event, or earlier.

13. PROTESTS

- 13.1 Any Protests must be lodged in accordance with the NCR.

14. SECURITY

- 14.1 Although the Event Organiser may provide security during the Event, competitors acknowledge that they are solely responsible for the security of their equipment and possessions.
- 14.2 With multiple vehicles in garages, it is the shared responsibility of all competitors within a respective garage to ensure it is locked at the conclusion of each day.

15. EXTRACTION TEST

- 15.1 In accordance with Motorsport Australia Extraction Test Policy ALL Competitors must pass the test once per calendar year to be able to compete. If you have not completed the test at a previous Event this year, you will be required to pass the test during the Event.

16. SCRUTINY AND VEHICLE REQUIREMENTS

- 16.1 Scrutiny at this Event will be conducted in accordance with Motorsport Australia's **Targeted Scrutiny** process. All vehicles must comply with the relevant category regulations and Circuit Race Standing Regulations of Motorsport Australia Manual.
- 16.2 The Chief Scrutineer will determine which vehicles will be subject to audit, and competitors will be notified at the time of event documentation. Competitors must ensure that their Motorsport Australia Log Book and all required safety equipment are presented as requested.
- 16.3 Any vehicle involved in an incident, or which undergoes a significant modification during the event, may be required to undergo further scrutiny before being permitted to return to the track.
- 16.4 Failure to comply with the requirements of Targeted Scrutiny may result in penalties, as determined by the Chief Scrutineer or the Stewards of the Event.
- 16.5 Logbooks will be retained and returned after inspections.
- 16.6 All competitors and drivers will be required to complete the Self-Scrutiny Statement of Vehicle Compliance form online. A link will be provided to the competitor and any drivers and must be completed before sign on / doc check.

17. TIMING EQUIPMENT AND ACCURACY

- 17.1 The event will use an automatic timing system that requires all cars to be equipped with a MyLaps transponder (Dorian timing devices are not compatible).
- 17.2 These are available for hire with your entry. The hire cost is \$30. Brackets are available from the timing team for \$15.
- 17.3 Timing will be electronic and to an accuracy of .001 seconds.
- 17.4 Failure to return the unit at the end of the Event and/or damaged units will result in \$950 (AUD) including GST being charged.
- 17.5 Transponder collection will be from **Level 2 of the Race Control Tower (Timing Room)** from 6:45am.

18. AWARDS AND TROPHIES

18.1 Trophies will be provided and awarded as per the relevant category's Sporting Regulations.

19. PIT LANE, PIT CREW & MARSHALLING AREA

19.1 **Pit Lane Speed Limit:** The maximum speed limit in the pit lane is 40 km/h at all times. Failure to comply may result in penalties, as per the Circuit Race Standing Regulations.

19.2 **Attire:** All personnel in the pit lane must be attired in accordance with the Technical Appendix Schedule D of the Motorsport Australia Manual.

19.3 **Access:** Only authorized personnel with appropriate wristbands are allowed in the pit lane and marshalling area. No person under 16 years of age is permitted unless they are competing.

19.4 **Equipment Restrictions:** No equipment may be placed on the pit wall during sessions.

19.5 **Safety Procedures:** Smoking and open flames are prohibited in the pit lane and marshalling area.

19.6 **Marshalling Area Procedures:** All vehicles must report to the marshalling area prior to sessions and comply with the start procedures as outlined in the event schedule and drivers' briefing.

19.7 **Pit Wall:** During the start of the warm-up lap and the first lap of any race, only Race Officials and Television crew specifically authorised by the Clerk of the Course are permitted on the pit wall.

19.8 All Competitors are responsible for the safe working conditions of all their Team Members and must ensure compliance with WorkCover NSW laws, regulations and compliance codes at all times.

19.9 Smoking (including e-cigarettes), spark generating devices, and any naked flame are prohibited in the pit area, pit lane, including the pit garages, at all times during the event. For the purpose of this clause the garages, carports and marquees located within the Paddock shall be deemed as included.

19.10 All Pit crew are required to complete the Motorsport Australia Risk Warning, Disclaimer and Indemnity form electronically as provided by the Event Organiser.

20. RESULTS

20.1 Results will be published on the Natsoft & MRA websites.

21. AUTHORITY OF OFFICIALS

21.1 Any competitor or persons associated with a competitor not following a reasonable instruction by an official during the Event will be reported to the Stewards and may be disqualified at the discretion of the Stewards of the Event in accordance with the NCR.

22. VENUE ACCESS

22.1 Gate open at 5:30am

22.2 Any competitor bringing a large transporter or truck should be at the venue by 5:30am (yes – 5:30am) and are to use Gate A only. Trucks/Transporters will be allowed to enter first.

22.3 The North Paddock will be busy, so please be kind and courteous to other competitors.

22.4 All competitors and crew must be out of the venue by 5:30pm on Sunday.

22.5 All competitors will be stopped at the North Paddock entrance to be issued a Support Vehicle Pass. Only accredited vehicles have access to the North Paddock.

23. CAMPING

23.1 Camping at the venue is prohibited.

24. MERCHANDISE SELLING AND/OR COMMERCIAL ADVERTISING

- 24.1 The selling of team merchandise, or other products, at the Event is Prohibited unless a merchandise agreement has been entered into with the Organiser. Details regarding sites and prices can be found at the Official Event website, including booking forms.
- 24.2 Commercial advertising of any product at the Event is Prohibited unless a written agreement has been entered into with the Organiser. Details regarding sites and prices can be found at the Official Event website, including booking forms.

25. OFFICIAL NOTICE BOARD

- 25.1 The Official Notice Board will be located on the MRA website.

26. VEHICLE WASHING

- 26.1 The washing of trucks, transporters, trailers or vehicles is strictly PROHIBITED at the Circuit and offenders will be referred to the Stewards.

27. WASTE PRODUCTS

- 27.1 Waste disposal points will be advised in Further Regulations.

28. VEHICLE DAMAGE AND OIL LEAKING – ON TRACK

- 28.1 Any driver who develops an oil leak or vehicle damage and does not remove the car from the circuit as soon as possible, or continues to drive their vehicle, may be sanctioned by Race Control, the Stewards of the Meeting and/or the Organisers. This matter will be treated seriously, and any consumables used will be at a cost of the competitor and/or additional penalties may include cancellation of a time set, a monetary fine and/or exclusion from the Event.
 - 28.1.1 Any fire extinguisher used to extinguish a fire in or around a vehicle will incur a charge of \$150.00 AUD per extinguisher, including GST
 - 28.1.2 Any drysorb or absorbent material used to clean up oil, fuel, or fluid spills on the circuit or in the pit lane will incur a charge of \$25.00 AUD per bag, including GST.
- 28.2 Any vehicle found to be leaking oil or fluids whilst competing will be suspended from the Event until the Chief Scrutineer / Clerk of course is satisfied that action have been taken to rectify the leak. Should there be a re-occurrence of the leak then the vehicle may face disqualification from the remainder of the Event.

29. RACECIEVER

- 29.1 It is highly recommended that all drivers in all race categories use a Raceceiver radio during all on-track sessions throughout the Event.
- 29.2 During competition, Race Control may communicate directly with drivers via the Raceceiver. Pit Crew are not permitted to relay messages or instructions from Race Control to drivers by any other means.
- 29.3 The Raceceiver operates on UHF frequency 450.4000 MHz. This channel is for one-way communication from Race Control to drivers only. Drivers and teams must not transmit on this frequency at any time.
- 29.4 Racereceivers will be available for purchase with entry at a cost of \$185.00 AUD per unit, including GST.
- 29.5 Drivers are encouraged to ensure their Raceceiver is correctly installed and operational prior to entering the circuit. No device capable of transmitting on the Raceceiver frequency may be

used at any time.

30. MYLAPS GPS TRANSPONDER

- 30.1 All Competitors must collect their allocated MyLaps RaceLink device at sign-on. It is the competitor's responsibility to ensure the device is correctly mounted in a location where the driver can see the indicator lights. Vehicles not fitted with a correctly mounted MyLaps RaceLink device may be directed by Officials to rectify the issue prior to taking part in on-track sessions. Marshals may visually check vehicles for the presence of the device.
- 30.2 These devices must be returned to the designated areas in the pitlane area after you have completed your last race or withdrawn throughout the day.
- 30.3 MyLaps RaceLink devices can be collected from Level 2 of the Race Control Tower (Timing Room) from 6:45am.
